You have been accused of the following criminal violations:

Section 647(i) of the PENAL CODE, a Misdemeanor;

To avoid having criminal charges filed against you in Superior Court, you must comply with the following;

1. You must appear in person at the Adult Diversion Services Office, 3315 Airway Drive, Santa Rosa, (707) 523-2242, between 8:00 a.m. - noon and 1:00 p.m. - 4:00 p.m., Monday through Thursday within 21 days of the date of this letter (see attached map). **YOU ARE TO APPEAR AT ADULT DIVERSION SERVICES AND NOT AT SUPERIOR COURT.**
2. Adult Diversion Services (ADS) is an alternative to criminal prosecution. ADS counselors provide direction, guidance and support for individuals seeking to make positive changes in their lives.
3. If you fail to contact Adult Diversion Services within 21 days of the stated date, criminal charges will be filed against you on the above criminal offenses.

ADULT DIVERSION SERVICES (ADS) is a pre-filing Diversion Program for individuals accused of misdemeanor crimes. ADS provides direction, referral, and support in the areas of personal growth, employment, and education.

When you are referred to ADS, you must sign-up **IN PERSON** within 21 days of the letter date. **FAILURE TO SIGN-UP WITHIN 21 DAYS WILL RESULT IN THE DISTRICT ATTORNEY FILING CRIMINAL CHARGES AGAINST YOU.** Sign-ups are Monday through Thursday, 8:00 a.m. to 11:30 a.m. and 1:00 p.m. to 4:30 p.m. **NO MONEY IS NEEDED AT THIS TIME.** An appointment will then be scheduled with a caseworker for a later date. That appointment will last one hour.

The cost and length of the program is determined by the criminal violation you are accused of.

Adult Diversion Services is offered by the District Attorney's office and is not criminal prosecution. The intention of ADS is to allow you the opportunity to handle your case outside of a court of law.

ADS is not a mandatory program and is to be entered into by choice. If you believe this would be your best alternative, you will be given detailed information about your participation in the program at your first appointment with one of our caseworkers. **COMPLETION OF YOUR CONTRACT WILL RESULT IN THE DISTRICT ATTORNEY NOT FILING CRIMINAL CHARGES AGAINST YOU.** Your participation will be tailored to your individual needs.

If you choose not to participate, ADS will send your case back to the District Attorney's office for filing of criminal charges, and you will have the opportunity to deal with your case in court.

**DIRECTIONS:**

**FROM NORTH 101:**

Take the Hopper Exit, turn right on Hopper Lane, turn left on Airway Drive.

**FROM SOUTH 101:**

Take the Bicentennial Exit (stay on left side), Turn right on Range Avenue, turn left on Piner Road, turn right on Airway Drive.

**FROM COURT:**

Take Ventura Blvd. to Bicentennial Avenue, turn left on Bicentennial, turn right on Range Avenue, turn left on Piner Road, turn right on Airway Drive.
